# **Presidents Report 2015/16**

The past year has seen a continuation of the usual HBK operations.

There has been an increase3d involvement with Bicycle Network Tas. with Matt the Social Rides Coordinator and also involved in the Bike Parking group. All of BNT events are covered by their insurance.

We have seen a continued increase in the number of Facebook Likes with over 1200 currently.

This coming year we will have to adapt to the loss of the Sustainable Living Festival as a means of connecting to more people, and the auction as our major source of income.

Suggestions include:

Bike of the Month: use eBay &/or Facebook to advertise a bike for sale each month. Pickup only. Payment via payPal.

Bernd has concerns about the security of a Paypal/Bank a/c integration. Matt and Bernd to explore.

Rattling the Tin: it may be useful to remind people that donations are welcome and give it more focus.

The tin should be placed in the appropriate location. Bernd has the combination and can call in regularly.

Membership and recruiting remain areas of concern.

Should we run some do you want to be a member sessions?

Before that we'd need to identify what is the value add for others.

Also need to investigate if there is benefit in registering with sites such as

Volunteering Australia or Seek Volunteer

Matt will also look at the UTas. Bike network (many of the bikes are going to Uni. Students, say 50 in the last 3 months)

The Bike Blender may also be a useful advertising tool.

We should also aim for 4 (physical) committee meetings per year, possibly alongside other, social events.

Mark will look at having a committee specific group to make it easier to do invites etc.., separate to the current Google group.

To support this it would be great to have someone with a specific event promotion role.

Thanks were extended to Steve and Alan for their continued efforts in running the Sunday Sessions.

We need to support them and improve communications in a way that works for them, making allowances for approp. technology.

We are currently Ok on for tools (except for the every disappearing 5mm hex keys). The racks are full, and could do with another cull.

HBK has continued to work with schools and Matt had recently donated a bike to Glenorchy Primary and has a number of bikes ready for the New Town Primary Fair.

# Hobart Bike Kitchen

Treasurer's Report, Financial Year Ending 2017

The financial year ending 2017 was saw comparable revenue to the year preceding but a sharp drop in our expenses, and advance in our cash position. This was expected and predicted with the FYE 2016 flagged as a heavy investment year for the kitchens, settling into new premises and outfitting them

Fundraising marginally outperformed last year, with the bike auction dominating once again.

Business as usual would see the kitchen advance its cash position yet again, but the auction has taken place at the Sustainable Living Festival the past two years and that festival will not run in the coming year. To wit, a new venue is needed for a bike auction and we face some risk of diminished revenue this year. The kitchen can operate the coming year with no bike auction revenue if needed, and he risk is not threatening this year, though longer term reliability of the Sustainable Living Festival needs to be appraised.

Follow last year's AGM, treasury explore the option of a PayPal account as an easy way to accept donations and send money to the kitchen. This was provisioned on PayPal offering comparable dual signatory security on expenditures, to that which the Bendigo Bank provides us. Cursory examination of PayPal policies suggests that's not possible, and that linking a bank account to a PayPal account will allow movement of funds into and out of the bank account without such security. A support request sent to PayPal to clarify (as their documentation is lacking in this area) has met with no response to date. A provisional PayPal account exists linked to the email address treasurer@hobartbikekitchen.org, but it is not linked to our Bendigo bank account and exists momentarily to facilitate support interactions with PayPal.
