Presidents Report 2017/18

It has been a very stable year for HBK with continued patronage of the Sunday Sessions throughout the year.

It has however, been difficult to maintain a session every weekend. With the chefs having their own commitments of a weekend we have missed a few sessions. The feedback from people getting to the sessions continues to be very positive.

There continue to be regular donations, to the point we have needed to do regular tip runs to remove the excess, unusable bikes and parts.

There have been ongoing discussion with the Wilderness Society regarding the possibility of their extensions meaning we will have to vacate the site for a lengthy period.

A number of options have been canvassed with the most positive being joining KickStart Arts and other groups at the St Johns precinct in New Town.

There are a number of benefits to this location.

We would be onsite with like minded groups such as KickStart, and Hobart City Farm who can support and cross promote each other.

The location is conveniently close to the Intercity cycleway, and St Johns Ave and the

New Town Oval bike track offers a much safer environment for people to test ride their bikes.

It is also close to New Town and Ogilvie High Schools which offers the chance to develop programs with those schools.

It is also recognised that a large percentage of those we work with come from the northern suburbs, so a location there puts us closer to the people who need our service.

We haven't made much progress from last year's AGM in terms of developing a recruiting strategy for new chefs, which is the biggest hurdle facing HBK. Being able to meet the current demand is dependent on the good will of a few. To meet that demand into the future, or to take up any of the opportunities which at times come our way we will need to ensure we continue to introduce new chefs.
